"I TOLD YOU SO"

I always have felt antipathy for "*cliches*," particularly the "*I told you so*" one. To me, it connotes a smart-alecky arrogance. But in view of what is going on in our Land today, goings-on that have been on the increase for years — that "*I told you so*" cliché becomes irresistible, because it is an undeniable fact that as far back as 1948 I have been warning the people of the horrifying events *to come* — and urging all loyal Americans to alert their friends and neighbors in their communities to take measures to forestall those events.

Actually, it was in the early 1940s that I first became aware (*vaguely, at first*) of the plot to make the Negro an instrument for the destruction of our nation. It was in Hollywood that I first became aware of it, when I saw White actors being replaced by Negroes in roles which only Whites could properly enact. I saw sections of scripts revised so as to seemingly require Negroes for roles for which they were totally unfit — I saw speeches put in the mouths of Negroes who had no conceptions of the meanings of those speeches.

In those early years I did not understand why the Negro had become such a prime favorite in Hollywood — and even on Broadway. It was not that I was opposed to the use of Negroes in plays and films. Through the years, when I had a play or a film that called for a Negro, I unhesitatingly employed one. Indeed, I always was opposed to black-facing a White actor to enact a Negro. But when I saw producers, directors, and writers putting words into the mouths of ignorant Negroes, words which they could hardly pronounce, let alone understand — Negroes who might fit into mob scenes, but hardly drawing-room scenes, I began to wonder. I was puzzled and bewildered. It was all so unprofessional.

It is common knowledge that just one miscast actor can ruin a play or a film (*or a TV show*). Most assuredly, important parts could be entrusted to a Stepin Fetchit, a Poitier, a Sammy Davis, etc., etc., if the roles called for Negroes. But here they were entrusting important roles to Negroes who were fit for nothing but "*Extras*," or, at best, "*bit*" parts. It all seemed so amateurish — this deliberate recklessness with valuable properties. What made all that so important was the fact that all those Moguls and Directors were not amateurs — anyway, not in-so-far as Motion Pictures were concerned! Hence my bewilderment — I sensed that there were far more sinister reasons for such doings. Then the pieces began to fall into place, via "*whispers*" from outraged casting directors, from self-respecting Directors and

Writers, from loyal Stars — I learned that the “*word*” was out throughout the industry: “*Build up the niggers*” — they didn’t even use the word “*Negroes*.”

Even so, I couldn’t understand their gambling with Million-Dollar Films. Of course, all the Moguls and many of the Directors were outright Reds: I knew that their chief objective was to further the Red Conspiracy in Hollywood. But how could casting apish Negroes in parts that imperatively required highly intelligent Whites help the Communist Conspiracy — it was a mystery that I just could not fathom at that time . . . nor did I *then* realize that it was not just to aid the Reds, but an integral technique of the overall Internationalist plot to drive the U. S. into their One-World trap.

But in 1952 I finally began to get the true picture. It happened at that year’s Republican Convention in Chicago. In my “*report*” of that event I described the methods that were employed by the CFR (“*Council on Foreign Relations*”) to steal the nomination for their tool Eisenhower. I described in detail the “*hush-hush*” meeting at which Warren delivered the California Delegation to Eisenhower — and Eisenhower agreed to appoint Warren to the U. S. Supreme Court, *as CHIEF JUSTICE, no less!* There was a vital reason for that “*Chief Justice*” proviso — that high post was to provide Warren the extra power and authority to issue “*Decisions*” that, *regardless of Congress and the Constitution*, would be declared to be “*Laws of the Land*.” The (1954) “*Desegregation Decision*” was actually decided upon at that “*hush-hush*” meeting — that “*Decision*” was to give a “*green light*” to the Negro Leaders (*all Communists and pro-Communists*) to take all Laws into their own hands.

The scheme to “*integrate*” Southern Universities and Schools was a distinct feature of that “*hush-hush*” meeting, with planned “*enforcement*” by flooding the Southern states with Federal troops and U. S. Marshalls, such as took place in Mississippi and other Southern states. And our phony “*Military Genius*” and all the “*Liberal*” (*who now call themselves “Moderate”*) Republicans who were present at that meeting enthusiastically endorsed the entire plot.

My “*report*” made it clearly obvious that the objective of that meeting was to inflame the Negroes throughout the South. Moreover, the “*Civil Rights Bill*” recently passed by Congress was a distinct part of the original plot . . . it was to have been the third-act climax of the “*play*.”

However, there is one thing that I am sure the plotters overlooked — they didn’t realize that when you start a prairie (or brush) fire on a windy day that fire will spread and spread and spread and all the fire fighters in the world can’t put it out until the fire burns

itself out. I am sure that they (*the plotters*) had planned to limit (*contain*) the main "fire" to the Southern states — they did not expect it to spread to all of the Northern states . . . *anyway, not in this election year!* But what they didn't realize was that the vast majority of the Negroes, even those of the fourth and fifth generation, are African savages whose "civilization" was never anything more nor less than respect for and fear of "White Man's Law" — the very same kind of "White Man's Law" that controlled the savages and cannibals in the Congo, in Viet Nam, in Indonisia, in all of Africa — the moment that "Law" was removed they all reverted to their natural savagery. That's what the "Desegregation Decision" did for the Negro (*ostensibly*) in the South — it removed his fear of the "White Man's Law" — it provided him with LICENSE to agitate, to riot, to loot, to rape *in the South!* But what the plotters didn't realize (*or overlooked*) was that the Negroes in the North would seize upon those very same "licenses" in New York, in Rochester, in St. Louis, in Chicago, in Washington, D.C., in Los Angeles, *everywhere.*

So now the plotters are panic-stricken. They realize they have lifted the lid on a Pandora's Box. They realize that there is a growing "backlash" among the Whites—and that it will grow and grow and GROW . . . that that backlash is creating a rage against all the "Liberal" Democrats and self-described "Moderate" Republicans — that it may well lead to a driving-out of all public offices of all the renegade "Liberals" and "Moderates" . . . particularly the Johnsons, Javitses, Cellers, Kuchels, etc., etc.

So now they (*the plotters*) are frantically appealing to those they set up as "Leaders" of NAACP, of CORE, of the Urban League, etc., etc., the Martin Lucifer Kings, the Roy Wilkinses, the Bayard Rustins and all the other Negro "reverends," to "restrain" their followers. That is, metaphorically speaking, like appealing to the Wolf-Pack Leaders to restrain their blood-maddened Packs. Even if willing to obey their new orders, I don't believe these "Leaders" will succeed — it has gone too far. Moreover, I don't believe that any of these "Leaders" want to "succeed" . . . they've tasted blood — they have gained powers they never dreamed of achieving — they won't stop now — they will have to be STOPPED — and stopped NOW . . . exactly as the wolf-packs are STOPPED! There is a particular reason why I say they must be stopped NOW. The reason? Significantly, in their "appeals" to the "Leaders," Johnson and the Masterminds stipulate that the "Packs" must be kept in restraint "until November 3" — obviously, that is a *tacit promise that after the election* they can go "all-out" again. And if a Kuchel or a Javits or a Johnson does not like my charges, *let him make the most of it!*

I conclude the above resume with this question: are 165 million White Americans going to surrender to 20 million African savages? Are we going to meekly surrender to the CFR plottings and the Warren "*Decisions*"? Or are we going to wrest our country back from their evil grasp? Are we going to let a phony "CIVIL RIGHTS" so-called "*Law*" deliver us to the un-tender mercies of a small minority of Negroes and their allies? Are we going to let renegades and traitors in the White House, in the State Department, in the Defense Department and various other Federal Agencies disarm us and deliver us into enslavement in a UN One-World Government?

Wake up, Americans! Let's take our Country back into our own hands. Let's drive the rascals and the renegades and the traitors out of Washington — and that goes for the U. S. Supreme Court and the "Liberals" in Congress as well! . . . LET'S PUT ONLY AMERICANS ON GUARD IN WASHINGTON ! ! !

"A PROPHET IS WITHOUT HONOR . . ."

As I previously stated, when I came back from that 1952 Republican Convention I issued a complete "*Report*" of all the chicaneries and crookedness perpetrated at that Convention. I pulled no punches. I revealed the complete "*sell-out*" . . . I warned of the betrayals that would come the moment the phony "*Military Genius*" would step into the White House . . . I warned of the chaos, the anarchy, the lawlessness that would be launched when and if the vomit-inspiring Earl Warren would become the Chief Justice of the U. S. Supreme Court — *and I provided documentary evidence for my statements.*

But do you think the people believed me? After I delivered speeches in San Francisco and Los Angeles, immediately upon my return from Chicago, many of our most loyal members and financial supporters demanded that I *publicly* retract my charges against the "*great*" Ike and Earl Warren — *or else they would resign.* I promptly accepted their resignations — *I never retract truthful statements!*

But that wasn't all that happened — that wasn't all the evil that came out of that Convention. From all over the country I began to receive letters from known fighting American patriots. All of them expressed great joy — all of them stated that with the "*great*" Ike in the White House we would have no further need of patriotic organizations — we could safely leave the fate of our country in the "*capable*" hands of Ike, the "*great humanitarian*," the "*great Administrator*," the "*great Military Genius*." We had a savior in the White House, they insisted, and we had nothing further to do or to guard.

As a result, our (CEG) membership became skeletonized — all patriotic organizations became skeletonized — many went completely out of business.

Oh, sure, after a couple of years, especially after all those Warren “*Decisions*,” most of those letter-writers became sadly disillusioned — and began to rush back into patriotic groups. Some new groups, such as the John Birch Society, came into being. But by that time inestimable damage had been done. And today we have a fight on our hands far, far greater than it would have been had we had a MacArthur or a Taft in the White House — had we had a Congress that had been held in line by the tempers of their constituents. Even if we had had an Adlai Stevenson in the White House we would have been spared the havoc of today — because we would have known we had an undisguised “*Lefty*” in the White House and all of his attempted betrayals would have been stopped in their very inceptions.

Thus, today, our only hope for salvation of our country is a dedicated AMERICAN (*and that certainly does NOT mean a Johnson*) in the White House — and a warned and tamed membership in both Houses of Congress.

With that, let me issue one more vital warning. I truly believe that Goldwater, if elected, will be an honest and *loyal American* Administrator. But let's not make the mistake of 1952. Let's *watch* our next President — let's watch every step he takes, everything he does. Let's not take him for granted. The same warning applies to *every* member of both Houses of Congress — let each and every one of them know that we are watching him exactly as Bank Examiners are supposed to be on guard against Embezzlers.

In other words, all of us must guard the safety and security of our nation today and henceforth — *as we should have guarded Pearl Harbor in 1941 . . . as we should have been on guard in 1952.*

FDR ONCE SAID: “WE PLANNED IT THAT WAY”

When Roosevelt made that statement nobody, *except he and his co-plotters*, knew what he meant. We assumed that he was referring to his personal political triumphs. We did not realize that he was referring to the over-all plot to enslave our nation within a One-World Government — we didn't know that that over-all plot had been carefully and *craftily* mapped many years ago. What he really meant was that he and his masters (“*Council on Foreign Relations*”) had out-Machiavellied Machiavelli.

Thus, even as late as 1952, I did not see the Negro disorders

as the beginning of the build-up into the sinister menace to our nation that it has become. I viewed those early flare-ups as something akin to the disorders created by the juvenile-delinquent gangs, and I was confident that if those disorders began to get out of hand the authorities would promptly pick up the leaders and give them the limit of the law. I was particularly convinced of that in 1951 when a mob of Negroes and White "*Liberals*" poured into the Los Angeles City Hall with a demand for the passage of an FEPC Law. Now, mind you, that very same law had been on a ballot several years earlier and been rejected seven to one! Nevertheless, one after another, the heads of the ADL, of NAACP, of the Urban League and of similar groups stood up and delivered frenzied spiels for such a local law, all loudly cheered and applauded by their coached clagues. Naturally, their demands were opposed by representatives of the Chamber of Commerce, of the "*Merchants and Manufacturers Ass'n.*," of CEG, of various Civic Organizations. The Council flatly rejected their demands for such a Law. In the blink of an eye that "*meeting*" was transformed into a near donnybrook — the "*Leaders*" and their Negro and "*Liberal*" White followers turned on their opponents with vilifications and threats of physical violence. The police promptly stepped in and ordered the mob to disperse. The order was obeyed — *sullenly and grumblingly*, but it was obeyed. I left the scene satisfied and convinced that we could depend upon the authorities to hold such mobs in line.

However, what I heard at that 1952 Convention gave me further — *and very disturbing* — thoughts. The most vital question that arose in my mind was: would the police be *permitted* complete authority in this matter? Then, in 1954, came the actual proof: the "*Desegregation Decision.*" And I realized that, in the words of FDR, it was all "*planned that way*" — that the Negro was to be the chief instrument in the Conspiracy to transform the U. S. into a racially strife-torn Congo . . . and thus create a "*situation*" for a UN "*Peace Force*" to step in to "*restore order*" — and take control of our nation.

I voiced my fears in one of our "News-Bulletins" right after Warren issued that "*Desegregation Decision.*" I actually predicted everything that has happened since then. But, as in 1952, various of our people jumped all over me — accused me of seeing "*ghosts.*" Some particularly criticized me for my charge that "*it was all planned that way*" in order to enable a UN "PEACE FORCE" to "*restore order*" and take control of our nation. Moreover, I think that even today some of our more naive people scoff at that charge. For those who scoff I have one very significant reminder, and that is the FACT that in 1951 the UN openly *invaded* eleven of the smaller cities in California, plus cities in Texas, Virginia and New York — invaded

them and *jailed* the Mayors, Chiefs of Police and other civic authorities. All this was done *ostensibly* without the knowledge of the White House, of the State Department and of the Pentagon — *despite the fact that the UN invading forces were composed of U. S. Soldiers*. But the important and SIGNIFICANT feature is that in response to questions the UN blandly proclaimed that all those “invasions” were merely “*rehearsals*.” . . . REHEARSALS FOR WHAT? — *the UN ignored that question!*

Another reminder for those who scoff is that greatly publicised “Operation Water Moccasin” in Georgia — and the planned similar “Operations” in various other states. *All those “Operations” were to have been UN projects* — and the vast majority of the “troops” in those so-called “War Maneuvers” were to have been Africans, Indonesians, Mongolians, etc., etc.

Is there still any doubt in *anybody's* mind that all those “projects” were steps in the plot to create a “UN PEACE FORCE” within the United States—to be held in readiness for a nation-wide “Negro Revolution?”

Anyway, as I previously stated, when I made the charge (in 1954) that the “Desegregation Decision” was the signal for the disorders, riots and (*finally*) a Negro revolution that was to lead to a take-over of our nation by the UN, it was greeted with disbelief — and even jeers. In my charge I stated that the plot to use the Negro as the chief instrument in the entire Conspiracy had been planned and mapped many years ago. I specifically charged that the “Desegregation Decision” was issued in order to aid and abet the entire GREAT CONSPIRACY in the following manner: A) *Create tensions between Negroes and Whites*; B) *To transform the South into a BLACK SOVIET REPUBLIC*; C) *To legalize and encourage intermarriage between Negroes and Whites—and thus mongrelize the American White Race*. I was promptly challenged by even some of my most loyal supporters — they demanded *documentary* evidence of that charge. *And there was the rub* — I had no *documentary* evidence. No matter how reliable my sources of information, no matter how much *obvious* evidence our researchers had uncovered, none of it was *documentary* evidence — it could readily be dismissed, *by those who did not want to believe*, as “*hearsay*” evidence.

And then, lo and behold, by the grace of God, in May 1957 I was handed the very documentary evidence I so sorely needed. It was embodied in the following excerpt from a book entitled “A RACIAL PROGRAM FOR THE 29TH CENTURY,” written by one Israel Cohen, a Communist Party functionary in England. That excerpt is as follows:

“We must realize that our Party's most powerful weapon is racial

tension. By propounding into the consciousness of the dark races that for centuries they have been oppressed by the whites, we can mould them to the program of the Communist Party. In America, we will aim for subtle victory. While inflaming the Negro Minority against the Whites, we will instill in the Whites a guilt complex for their exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige the Negro will be able to intermarry with the Whites and begin a process which will deliver America to our Cause."

That book was published in 1913, but it was written at least two years earlier — as I will later show . . . and the NAACP and the "Anti-Defamation League" were set up immediately after that — to carry out those DIRECTIVES

That excerpt was published by the Washington (D.C.) Evening Star in May 1957, together with the title of the book and the name of the author. It was entered into the Congressional Record of June 7, 1957, by Rep. Thos. G. Abernathy — after he had carefully checked with the "Star" and was assured of the existence of the book.

And then I uncovered further "DOCUMENTARY" proof: in 1935, the Communist Party's "Workers Library Publishers" issued a pamphlet entitled "THE NEGROES IN A SOVIET AMERICA." It urged the Negroes of the South to rise up, form a Soviet state, and apply for admission to the Soviet Union . . . it contained implicit assurance that the "revolt" would be supported by all American Reds . . . on page 38 it promised that a Soviet government would confer greater benefits on Negroes than upon Whites, and that — "Any act of discrimination or prejudice against a Negro will become a crime under the Revolutionary law . . ."

AND THAT "DESEGREGATION DECISION" TRANSFORMED ALL THOSE COMMUNIST DIRECTIVES INTO RIGID LAW OF THE LAND !!!

Furthermore, by his own admission, Warren ignored our Constitution when he wrote that "Decision" — admits he based it on the "modern scientific authority" of known Communists who have publicly proclaimed contempt for our Constitution and hatred for our form of Government.

Can there be any further doubt that that "Decision" was framed to conform with the directives in the Israel Cohen book and the "Workers Library Publishers" pamphlet? . . . There is one sure way to find out — through impeachment proceedings!

As I have stated, immediately after Warren issued his "*Desegregation Decision*" we issued a "*News-Bulletin*" devoted to that entire treasonous act. We bluntly charged that that "*Decision*" was intended to incite a nation-wide Negro Racial Uprising — and that it was a carefully worked-out sub-plot of the Great Conspiracy . . . some called it a sub-plot of the Communist Conspiracy, but let's stop kidding ourselves: the Communist Conspiracy is distinctly an adjunct of the over-all Great Conspiracy.

Naturally, the ADL, the NAACP, the ADA and all the other "Liberal" groups came roaring to the defense of the man who already had been dubbed "*the Red Bloated Toad of the U.S. Supreme Court*." They all screamed that his "*attackers*" were Anti-Negro and Anti-Semitic Rightist-Extremists and Rabble Rousers . . . *they left it to the Kuchel character to coin the "fright-Peddlers" label.*

However, early in June of 1957 we launched our Hydrogen Bomb — the "*SCJ Tract No. 1*." What made it such a shattering "*bomb*" was the Israel Cohen excerpt, which even a grade school child could easily recognize as a set of directives to use the Negro to destroy the unity of the American people.

ADL ORDERS: "KILL THE SCJ TRACT!"

That "*Tract*" literally stunned the plotters. All the growing "*Racial Disorders*" were so startlingly in line with the "*directives*" revealed in that "*excerpt*" that it provided irrefutable proof that all those "*directives*" had for many years been in actual operation—it left the plotters with no "*way out*" via denials or alibis. They knew that there was only one way for them to escape the wrath of the American people — *and to preserve their plot*: "*SCJ Tract No. 1*" would have to be "*spurlos versenkt*" (sunk without a trace) before ALL the American people became aware of it.

In our "*News-Bulletin*" No. 99 I revealed in detail the Machiavelian machinations employed by one Alfred Kohlberg to "*establish*" that there never was an Israel Cohen — and that therefore there never was any such book as "*A RACIAL PROGRAM FOR THE 20th CENTURY*." I described how he waited two years before putting his plot into action — in order to give the ADL sufficient time to ferret out and destroy every copy of that book.

In that "*News-Bulletin*" I also recited that immediately after we launched our campaign for the impeachment of Warren several other Patriotic Organizations promptly joined with us on that project — and helped to circulate our publications, particularly our "*SCJ Tract*." In addition, other Groups with nation-wide followings

initiated their own campaigns for the same objective — they issued their own literature, many of them reprinting that Israel Cohen “*excerpt*.” But immediately after Kohlberg induced the “*Washington Star*” and other publications to spread the word that the “*excerpt*” was a “*hoax*” practically all the Patriotic Groups hastily dropped the “*excerpt*” from their literature.

Now, here I wish to stress a very vital point — *for the benefit of all Patriotic Organizations*: Alfred Kohlberg was a highly regarded member of “*The Council*” of one of the best known pro-American Organizations. In addition, he was a close friend, indeed more or less a palsy-walsy, of the founder-head of the organization. In all his efforts to discredit the Israel Cohen “*excerpt*” he used that organization as his “*umbrella*.” Furthermore, even today, although Kohlberg is now dead, the “*Public Relations*” head of that organization continues, in so many words, to “*warn*” their contacts and members that the “*Israel Cohen excerpt*” is a myth.

(NOTE:— We (CEG) have rigidly maintained a rule to refrain from criticising the activities of other Patriotic Organizations. In other words, we will not fight with “our own.” Therefore, I will not name that (Kohlberg) organization. MCF)

“BEWARE OF GREEKS BEARING GIFTS”

Today, fully as much as in the ancient days when it was first uttered, that warning is a matter of life and death for our nation. Here is why that warning is so *extremely* vital: Through the years, the “*Enemy*,” the CFR, and the ADL, have employed a very crafty technique; to wit: the moment a Patriotic Organization begins to loom up they promptly infiltrate it with their “*undercover agents*.” These agents then employ various tactics to worm their way into “*top places*” within the Group — usually a generous contribution (“*GIFT*”) is the most effective trick — and soon they emerge as the “*guiding spirits*” in those Organizations. Alfred Kohlberg is one of the best examples of that “*technique*.” Kohlberg was a very generous contributor to a number of Patriotic Groups — and thus was able to keep the ADL and the CFR fully informed of the planned activities of such Groups. He made an almost fatal mistake when he helped to set up the treasonous IPR (“*Institute of Pacific Relations*”), but somehow or other he was able to retain the confidence of many Patriots . . . And that’s my point: I sincerely hope all Patriotic Groups will heed this warning — and carefully screen their “*Boards*” for lurking “*Greeks*.”

NOW COMES THE RE-AWAKENING

It was in 1960 that the ADL and Alfred Kohlberg intimidated the various Patriotic Group Leaders into abandoning the use of that "*Israel Cohen excerpt*" to alert the people. I am confident that had all of the American people read that "*excerpt*" — *and observed how slavishly the Negro Leaders were carrying out its "directives"* — they would have FORCED all of our Authorities, *even those who are eagerly selling their birthrights for the Negro vote*, to take drastic measures to rigidly quell all Racial disorders. But the vast majority of the people are unaware of that "*excerpt*," and thus four precious years have rolled by — four years in which, encouraged by both Kennedy and Johnson, the Negro riotings mounted and mounted and mounted. At long last, however, it is obvious that the American White people have a bellyful of the Negroes' "*fight*" (*Rioting—looting—murdering*) for their "*rights*" — a bellyful of the Kennedy-Johnson plot to flood the voters' rolls with the registration of millions of Negroes who never even wanted to vote—a bellyful of the Johnson billion dollar "*war on poverty*" plot to pour hundreds of millions of dollars of "*relief*" money into all the "*Harlems*" in America. During the past several months, particularly since Johnson forced the passage of the "CIVIL RIGHTS" law, we (CEG) have been flooded with letters from all over the country — among the writers being many of the Patriotic Group leaders who had been *frightened off* from use of the Cohen "*excerpt*." Now they clearly *and horrifiedly* realize that all of the "*Racial Disorders*" are truly directly in line with the "*directives*" in the "*excerpt*" — and they are anxiously seeking ways to get that "*excerpt*" to all their people. Nevertheless they are still fearful of ADL reprisals — and they *plead* for some kind of evidence, any kind, that the Cohen "*excerpt*" has a basis of fact. My answer should be that the *original publication* of the "*excerpt*" by the "*Washington Star*," fortified as it was by the verbatim insertion of the same "*excerpt*" in the "*Congressional Record*," should be sufficient proof — especially as in "*News-Bulletin*" No. 99 I so completely established that the "*attack*" on the "*excerpt*" was masterminded by the ADL provocateur Kohlberg. However, recently I discovered (*reminded is the better word*) another very significant episode that should most assuredly serve as PRIMA FACIE evidence, not only of the existence of Cohen and his book, but that the entire "*Negro*" plot was launched back in the early years after the turn of this century.

ANOTHER ISRAEL

Back in (*approximately*) 1909 another Israel, last name Zangwill, wrote a book in which he "*deplored*" the "*persecutions*" suffered by "*Minority Groups*" in the United States. But, according to his book, the only "*Minority Groups*" that were suffering "*persecution*" by the American people were Jews and Negroes. The title of that Israel Zangwill book was "THE MELTING POT." In many ways that book (*as also the Israel Cohen book*) was more or less a forerunner for the more recent book by Swedish Socialist Gunnar Myrdal which served as the blueprint for Warren's "DESEGREGATION DECISION." Immediately after his book was published, Zangwill transformed it into a play, also titled "THE MELTING POT." The central figure in the play (*also in the book*) was a Jewish 16 year old boy who "*showed great promise of becoming a violin virtuoso*," but who was unable to show his genius because he was a Jew. All efforts of the boy's parents to stage a "*concert*" for him at Carnegie Hall (*New York*) were balked — *because he was a Jew!* Finally, however, after a (*mythical*) New York newspaper entered the controversy on behalf of the "*persecuted boy virtuoso*," the Carnegie Hall Management capitulated and set a date for the "*concert*."

But that was not the end of the imbroglio — unbeknown to the Carnegie Hall manager, the piano accompanist chosen by the "*boy virtuoso*" was a young Negro. The manager promptly cancelled the engagement — and once again the controversy hit the *mythical* front-pages. But on that point the management remained firm — and the "*boy virtuoso*" finally accepted a White accompanist. The concert was a "*terrific success*" — the boy was hailed as "*the greatest violinist of the century*" . . . *all of that was highly dramatized in both the book and the play.*

Thus Zangwill "*proved*" his point that our "*persecutions*" rob the world of genius simply because of race and color. The play showed that the Jewish boy was a genius — and the final note was that the "*persecuted*" young Negro pianist, too, might well have proven himself a Chopin if the American White people had given *him* an opportunity.

Now, here is how the above described Zangwill episode has a direct bearing on the Israel Cohen matter:

Israel Zangwill, like Israel Cohen, was an English Jew — only he was a far more famous literary figure than Cohen. Both were closely tied in with George Bernard Shaw's Fabian movement, then flourishing in London. Both contributed "*articles*" to the same Fabian-Marxist publications. The writings of both were in the same

Marxist vein — and both eulogized and quoted each other in their writings. But most important is the fact that Zangwill's "*The Melting Pot*," both the book and the play, were *directly* in line with Cohen's "A RACIAL PROGRAM FOR THE 20th CENTURY." As a matter of fact, Zangwill's "THE MELTING POT" might well have been Cohen's inspiration for *his* book.

Now let's see how far the ADL will go to "*establish*" that Zangwill and his play, too, are Myths. It was comparatively easy to declare non-existence of Cohen, but Zangwill was a far more famous writer — his play, if nothing else, is "*history*" — Broadway theatrical history — it can not be erased.

FURTHER PRIMA FACIE EVIDENCE

There is an old saying to the effect that "*the proof of the pudding is in the eating, etc.*" Very well — let's now take a few citations from that Israel Cohen "*excerpt*," analyze their objectives with all fairness, and see how they have been carried out from the very outset — *to these very days!* That will prove beyond even a remote doubt the authenticity of that entire "*excerpt*."

Two of the directives in the "*excerpt*" state: "We must propound into the consciousness of the dark races that for centuries they have been oppressed by the Whites" . . . And . . . "while inflaming the Negro Minority against the Whites, we must instill in the Whites a **GUILT COMPLEX** for their exploitation of the Negroes" . . . Thus to reduce the resistance of the American people.

Even those who run as they read must be able to see how well those two "*directives*" have been — *and still are being* — carried out by our Press and by ALL other Mass Communications Media, *especially TV and Hollywood*.

Now let's pause a moment and appraise that **GUILT COMPLEX** "*directive*:" All of our Mass Communications Media, with very few exceptions, have been copiously shedding tears for the "*poor Negroes*" — wailing about the injustices done them by the Whites during (*at least*) the hundred years since Lincoln emancipated them — how they have been deprived of all their rights, etc., etc. All of that went into higher and higher gear after Roosevelt entered the White House.

Moreover, it is common knowledge that Henry Ford II has been pouring MILLIONS of dollars into the various Negro organizations, such as CORE, NAACP, URBAN LEAGUE, etc., etc. Ditto the Marshall Field family — ditto the Lamont family — ditto the Julius Rosenwald family — ditto the Rockefellers, etc., etc. All that to finance the Negro "*revolution*."

However, with regard to the preceding paragraph, we must not overlook the most vital point: Not all of that financing of the Negroes is motivated by a GUILT COMPLEX, or by real sympathy for the "*poor Negroes*" — virtually all of it is in line with the overall CFR One-World plot. We know that Nelson Rockefeller is one of the "*top brass*" of the CFR — virtually all of the Rosenwald-Stern family are frenziedly supporting that same CFR-ADL One-World plot . . . all those "*Bleeding Hearts*" are simply using the Negroes to further their plot *exactly as directed in the Israel Cohen "excerpt!"*

Another of the Cohen "*excerpt*" directives reads: "We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment . . . With this prestige the Negro will be able to intermarry with the Whites and begin a process which will deliver America to our Cause."

Look about you again, my fellow-American, and see how well that twin-directive has been, *and is being*, carried out:

TV Executives and Advertising Agencies are frenziedly carrying out the first part of that "*directive*." This year, as never before, TV shows are aiding and abetting the Negro "*revolution*." Negro so-called actors are getting roles that *demand* Whites. Advertising Agencies are actually instructing producers to increase Negro casting "*for the good of sales*" . . . There is a Negro teacher in "*Mr. Novak*," a Negro secretary in "*East Side-West Side*," Negro students in the class-room of "*The Patty Duke Show*" and on the campus of "*Channing*." On "*The Outer Limits*," a negro recently played a would-be Pierre Salinger, press secretary to a Presidential Candidate. Another "*Outer Limits*" show is scheduled to have a Negro astronaut. All three networks now have Negro newsmen. There are Negro girls in Jackie Gleason's chorus — ditto in virtually all other choruses. A Chicago TV station has a Negro weather girl . . . Various shows such as "*The Defenders*," "*The Great Adventure*" and "*The Fugitive*" are fighting for the services of Negro actors such as Ossie Davis, Ruby Dee, Diahann Carroll, etc., and "*co-star*" them. "*Perry Mason*" had eight Negroes on one recent show — "*The Nurses*" had eight that same night, one addict, two Extras and five R.N.s — "*The New Phil Silvers Show*" has a regular Negro. All "*Court-room*" shows frequently have Negro Judges.

The list of Negro roles is constanly growing, but now we find even more significant concrete evidence in TV Commercials: A Negro shaved with a Gillette razor between innings in last year's World Series . . . Rambler Commercials use Negroes — so do Commercials for All, Whisk, Oxydol and other detergents, "GLEEM" and other tooth pastes . . . When a movement in TV reaches the

Commercials, it can truly be said to have reached the heart of the matter!

In Hollywood, Negroes have been shut out of "*My Fair Lady*" — *but nothing else!* Central Casting is paying out more than seven times as much cash for Negro "*Extras*" as it was a year ago. Connie Frances goes to a mixed party in "*Looking for Love*." Robert Goulet and Robert Morse share a Negro secretary in "*His and His*." Ossie Davis is a Catholic priest in "*The Cardinal*." Negro couples and mixed couples are guests at a cocktail party in "*The Out-of-Towners*" and are spectators in formal dress at a Paris art exhibition in "*What a Way to Go*."

On Broadway there were 20 Shows last season in which parts were filled by Negroes, *parts which distinctly called for Whites!* Despite that, pickets paraded outside of "*How To Succeed*" and "*Subways Are For Sleeping*" because there were no Negroes in either cast. Now David Merrick, who produced "*Subways*," is putting Negroes (*in unnecessary bit parts*) into his new productions, "*110 in the Shade*" and "*One Flew Over the Cuckoo's Nest*."

Now let's take up the latter part of that "*directive*," the part that predicted: "*With this prestige the Negroes will be able to intermarry with the Whites*" . . . : Sammy Davis, Jr., an ape-like little Negro married a white female . . . an Ertha Kitt, publicized and eulogized out of all proportion to her meager talents, marries a White man . . . Paul Robeson married White females — and that is true of scores of Negroes in the professional worlds. And the most sickening ironic feature of all that is that of **approximately 1,200 inter-racial marriages performed during this past year, 90 percent were between White women and Negro men!** That is the known record — there may be far more! And now, with integration being **FORCED** upon our schools and Universities, **White students are marrying Negroes!**

Now, one might ask: how do all the Negro "*actors*" and "*actresses*" acquire all that "*prestige*"? The answer is very simple: all dramatic critics (*Press, Radio and TV*) are *under orders* to acclaim the performances of the Negroes, no matter if the show itself turns out to be a "turkey."

What greater evidence do we need that the Israel Cohen "*excerpt*" is a true blueprint of the plot to use the Negro to destroy the unity of the American people — *and to mongrelize the White Race?*

Now let me highlight how our so-called Leaders in Washington, *on orders from the Masterminds of the Great Conspiracy*, have been, *and still are*, collaborating with those Israel Cohen "*directives*" — how they are using every possible means to force surrender by the White people to all Negro demands.

We know what Warren's "*Desegregation Decision*" has done to our Schools and Universities. Equally horrendous, that "*Decision*" was intended to open ALL doors to Negroes — not only doors of schools, hotels, motels, restaurants, theatres, etc., etc., but private housing as well — it enjoins even the "*Mrs. Murphys*" from "*discriminating*" against Negroes who might insist on moving into their private boarding houses.

All of the Negro "*marches*" on Schools, Banks, Hotels, Housing Developments, Industrial plants, construction projects, private business establishments, etc., etc., are too fresh in our minds to require review in these pages. The "*Leaders*" of such Negro mobs instruct their people to not only "*picket*" all such establishments, but to *invade* them in large numbers — *in order to disrupt business*. These mobs do not invade such places for an hour, or even for a day — they "*sit-in*" for a week, or a month, if their "*Leaders*" see fit . . . and the civic authorities and "*Judges*" order the police not to interfere with them — *indeed, the police are ordered to protect the "pickets!"* A classic example of that amazing attitude by our "*authorities*" was the months-long invasion of the Don Wilson Housing Tract in Torrance, California: All the home owners in that area were ORDERED to vacate the streets, so as to give the "*pickets*" and the "*sit-inners*" full freedom of the streets. On top of that, the same "*authorities*" provided the "*pickets*" with blankets, mattresses and sleeping-bags, so that they could do their "*picketing*" in comfort!

In all this there is one vital point that is generally overlooked: under our *Constitutional laws* all such "*sit-ins*" and "*invasions*" come under the distinct heading of unlawful trespass — *yes, and ALL Judges know that!* Before Warren's "*Decision*" flashed the green light for the Racial Upheavals all such trespassers would have been arrested and jailed — but, today, particularly since the passage of the "*Civil Rights Act*," if any White Merchant, say a Restaurant owner, resists such *trespass* he is subject to arrest on any one of a number of charges.

At this point it becomes important to stress the reasons for the frenzy with which Kennedy (*Martyr Jack*) and Johnson pressed Congress to enact the "*Civil Rights*" Bill. First of all, bear in mind that both of those despicable political opportunists, *until they entered the White House*, had always obstinately opposed all "*Civil Rights*" Bills. In 1954 the "*Masterminds*" ordered Earl Warren to issue his absolutely lawless "*Desegregation Decision*" — on the theory that, in the absence of a Congressional "*Civil Rights*" Law, that "*Decision*" would be accepted as a "*Law of the Land*." But, alack and alas (*for the Masterminds*), it didn't quite work out that way. True, the phony "*Military Genius*" then in the White House made that "*De-*

cision" his excuse to send THOUSANDS of troops to Oxford, Mississippi, plus hundreds of thugs hastily given U.S. Marshal badges, to force the University to enroll an ineligible Negro — the same "Decision" also was the weapon used against the valiant Governor Wallace of Alabama, but it (*the "Decision"*) came a cropper in many other instances — industrialists, Hotel and Motel and Restaurant owners jeered and defied the "Decision" — and in *many* cases the local judiciary approved the defiance. Hence, a "Civil Rights" Law became a MUST with the "Masterminds" — and both Martyr Jack and Wheeler-Dealer Johnson bowed to their demands.

(That is why the "Masterminds" are so frenziedly employing every possible trick to keep Goldwater out of the White House — they feel, and I believe rightly so, that he would move to repeal that "Law.")

The Congressional enactment of that Law did the trick — no Judge could condone defiance of such a Law. What the Warren "Decision" could not do, the "Civil Rights" Law is doing. Following are just two examples:

Throughout the decade since Warren issued his "Decision," Lester Maddox, owner of a \$400,000 Restaurant, defied it, and successfully refused to permit Negroes to enter his place of business. But immediately after "Civil Rights" became a Congressional Law, he was hauled into Court and cited for "Contempt." Mr. Maddox, true to his convictions, *closed* his Restaurant. Another case involved the finest (300 room) hotel in Atlanta: throughout the "Decision" decade the owners continued to refuse rooms and service to Negroes on the ground that the "Decision" was unconstitutional and illegal — and no Judge found the owners "guilty." But they could not defy the Congressional "Law," so they gave up the fight — *and closed the hotel!* — they refused to surrender to the Negroes. And there are many similar cases throughout the South.

NOW THE BOOMERANG

As those of us who need no "crystal ball" are fully aware, the "Racial Revolution" was intended to create a condition in our country that would "require" UN intervention — and finally culminate in that "One-World" objective of the Great Conspiracy. And, as we know, our "Leaders" in Washington have been zealously collaborating with the plot by "handcuffing" State and Municipal authorities.

And as we know, the "Desegregation Decision" was *deliberately* intended to serve as the "green light" for this general "Racial Revolution" — but, actually, it was intended to confine the "Revolu-

tion" to the South, in accordance with the Israel Cohen "excerpt" and the "directive" in the Communist Party's "THE NEGROES IN A SOVIET AMERICA." The latter distinctly addressed itself to "The Negroes of the South." And that's where their scheme went awry, to wit:

What the "Masterminds" overlooked was that when they gave the Negro the "green light" to "fight for his rights" they were not dealing with the naturally civilized White man — they, seemingly, did not realize that the Negro is still innately a savage; that, although he is two hundred years and thousands of miles removed from his native Africa, "self-restraint" is completely foreign to him, and that his past "good behavior" was based on fear of "White Man's Law" — *the same fear that finally subdued our Indians . . .* the plotters overlooked that underneath his "civilization" the Negro needs but an excuse to revert to his natural (savage) instincts. That "excuse" came into being when unscrupulous white men (renegades), at the behest of the One-World conspirators, began to "whisper" to the Negro that he has been "persecuted" by the White man; that he still is being "persecuted" despite his emancipation from slavery; that the White man looks down upon him as an inferior "animal." And that rekindled the (Negro's) long-dormant, *but never dead*, instincts of lust and unbridled passions — the "DESEGREGATION DECISION" was the spark that unloosed the leash (*the enforced self-restraint*), the "CIVIL RIGHTS" Law completed the unleashing — *and served as the big wind to spread the flame of the "Revolution" throughout the nation!*

In short, to paraphrase Gertrude Stein, a Negro is a Negro is a Negro. The plotters kept inflaming the Negroes in the South to revolt and riot in the hope that it would throw the entire South into chaos and anarchy — and finally cause the Federal Government to capitulate to the demands of the Negro Leaders and the Black Muslims that those Southern states containing the heaviest concentration of Blacks be transformed (*crazy as it may sound*) into a Negro Republic — and, believe it or not, *but you better believe it*, our "Leaders" in Washington, such as the Kennedys, Johnson, Hubert Humphrey, Jake Javits, Kuchel, etc., were more than just receptive to the idea. But, I repeat, that's where the schemes of the plotters went awry: they definitely wanted to confine the "revolution" to the South; they kept baiting the Southern Whites to resist and thus create the bloodshed and anarchy they wanted — thus making all Southern Whites vicious "Ku Kluxers" in the eyes of all the White people in the so-called North — and create "sympathy" for the Negroes. But, to the consternation of the plotters, Negroes being what they are, the "revolution" quickly spilled over

into all other States — and that, as the saying goes, “*spilled the beans.*”

As a result, I predict here and now that this “*revolution*” will not bring success for the plotters — its spread to the North has already infuriated all the White people (*except the “Liberals”*) in our nation. This “*revolution*” WILL be smashed by THE PEOPLE! — It will bring great bloodshed — it may even erupt into actual “*civil war*” between the Whites and the Negroes — but it WILL be put down!

WHAT'S THE MATTER WITH OUR PEOPLE?

When the phony “*Military Genius*” (Ike), in compliance with the “*Desegregation Decision*,” unlawfully invaded the sovereign state of Mississippi with THOUSANDS of troops and so-called U.S. Marshals to force the enrollment of Negroes in the segregated Schools and University of that State, the American people, outside of the South, while shocked, approved the invasion — and loudly expressed sympathy for the “*poor Negro children*” . . . the same people expressed horror when the heavily outnumbered police of Birmingham were forced to use dogs and fire hoses and cattle goads to quell the rioting Negroes and prevent their “*take-over*” of the city — all those “*good people*” cried out against the “*Police brutality*” . . . they decried in similar manner when Governor Wallace tried to prevent the integration of the schools in his State.

But, suddenly, there came the change. The Negroes in Northern cities under the leadership of the same kind of *Communist* Negro Leaders, joined in the “*Revolution*.” First they launched “*non-violent*” drives for their “*rights*” — “*non-violent*” marches, “*non-violent*” picketing, “*non-violent*” sit-ins and disruptions of businesses, large and small. But I have always contended that the Negro mobs can be no more “*non-violent*” than so many tigers on the loose. And following events proved me completely correct. I don't have to go into the details of the Negro murderous riots in Harlem, in Brooklyn, in Rochester, in New Jersey, in the Chicago area — the Press and Radio and even TV tell the story every day. And almost overnight, the Northerners are ceasing to sympathize with the “*poor persecuted Negroes.*” No longer do they declare smugly to the Whites of Mississippi and Alabama, “*We are holier than thou.*” It has become crystal clear that the gravest “*racial problems*” today are in the Northern industrial centers, not in the South.

There is one very valuable lesson from those murderous riots of New York and Rochester and other cities. We ought to learn the following hard truths from these riots:

First, the "CIVIL RIGHTS" Law and all other formal legislation concerning abstract rights can not bring racial harmony. The rioters in New York and Rochester enjoyed at least as many rights as did their White neighbors — they had integrated schooling, open occupancy, freedom to service in hotels, theatres and restaurants — they had equality in employment opportunities, etc., etc. The cry of the Negro is that he wants "*equality*" — But Black is Black and White is White — *the Law and the Courts can't change that*. The hard fact is that the Negro does not want equality — he wants *SUPERIORITY!* That may sound utterly fantastic, but it is true.

Now, one might wonder what could have created such a crazy phantasy in the collective mind of a people who, in the main, are more fit for the jungles of Africa than for our American society. If anybody objects to that statement I suggest that he take another look at the hordes of Negroes, *men and women*, who turn out for those bloody riots. The answer to all that is very simple: Their leaders, the Martin Lucifer Kings, the Wilkenses, the Adam Clayton Powells, etc., all outright Communists and/or Red Fronters, all direct stooges and tools of the CFR-ADL conspirators, have "*sold*" the ignorant and childishly credulous masses of the Negroes that for them a new Era is dawning — an Era in which the Blacks will be the Master Race in America — and that not only will the South be transformed into a "*Black Republic*," but that before many years elapse a Black man will occupy the White House. Crazy? But the vast majority of the Negroes believe it.

WHO IS REALLY TO BLAME?

Frankly, we, the American people, actually have no one but ourselves to blame. We, *the people*, have the power to be the masters of our destiny, but for more than thirty years we have been electing into our highest offices, *particularly the White House*, renegades who accept the "*silver*" of the Masterminds of the Great Conspiracy to betray us into their "One-World" enslavement — *exactly as Judas accepted the 30 pieces of silver to betray Jesus Christ!*

Lest some may resent or refute my charge of our collective stupidity in our choice of the "*Leaders*" in Washington — yes, and

in States and Cities — let me briefly pinpoint the proof of that charge: in 1932 we elected Franklin Roosevelt who even then was a known charlatan and political opportunist. In his very first term he clearly revealed himself to be a crook, a traitor and a tool of the Masterminds of the Great Conspiracy, yet we thrice re-elected him to continue to betray and betray and betray. If you have the slightest doubt of *that* statement, read John T. Flynn's shocking "*The Roosevelt Myth*" . . . Next came Harry Truman — do I have to review the acts of that "*gentleman*" of the Kansas City underworld? He tried, *frenziedly*, to protect traitor Alger Hiss and all the other traitors in his Cabinet — *he confirmed* the delivery of East Berlin to Stalin — he hurled us into the Korean War — and to prevent our winning it, he fired Gen. MacArthur, our greatest Military Genius of at least this century . . . Next came Eisenhower, the PHONY "*military Genius*;" do you remember how the vast majority of our people hailed him as our "*Savior*" when he entered the White House? If you don't know what an opportunist and phony he has been from his early teens to this very day, get a copy of "*The Eisenhower Myth*" News Bulletin. Throughout his life he has been luxuriating on the same kind of "*silver*" that Judas accepted to betray his Lord. Throughout his career he has been a faithful stooge and tool of the (CFR) Masterminds of the Great Conspiracy — *and let's not forget that it was Eisenhower and his gang who originally planted Castro in Cuba* . . . Next we turned the White House over to John F. Kennedy, a notorious Night Club brawler from his very teens, a notorious libertine, a liar and a perfectly willing-to-be traitor; in his less than three years in the White House he turned every trick he could think of to deliver us into the UN One-World trap — it was Kennedy who concocted the unilateral "DISARMAMENT" plot, and tried and tried and tried to force Congressional action to disarm the entire citizenry of our country, so that we could not defend ourselves when the UN would renew their "*Aggressi*" invasions of our cities — *such as our armed citizens brought to a halt in 1951* . . . And now we have Johnson in the White House — a man who actually shudders when he hears such words as honesty, integrity, honor, decency, loyalty — a man who poses as a "*Southerner*" in the South, a "*Westerner*" in Texas, a "*Northerner*" in New York — he is the man who called into conference all the "*Leaders*" of the Negroes and ordered them to cease all Racial disorders until the day he is elected — with the implicit implication that after he is re-installed in the White House they could set the whole nation aflame with their Racial riots!

Now do you know why I say that we have *ourselves* to blame for all our troubles? For more than thirty years we *stupidly* elected would-be destroyers of our nation into the White House — and permitted them to fill all Federal Agencies with tools and stooges

of those (CFR) plotters who are hell-bent to enslave us in a Communist One-World government . . . *yes, and we also elected equally traitorous men and women into both of our Houses of Congress!*

Very well. We were stupid, we were naive, we were thoughtless and careless. We can cry out with the (*paraphrased*) words that Jesus pleaded from the Cross: *Father, forgive us, for we knew not what we did.* But now we DO know! We cannot again cry out for forgiveness and for the salvation of our nation if we fail to heed the warnings provided by our knowledge.

I have stressed all of the above for a very vital reason: Today we are facing an election — we have a choice. Our choice means LIFE or DEATH for our nation. *What are YOU going to do about it on November 3?*

There is another vital point I wish to stress: I have indicated that all of our people now know what frightful mistakes we've made since 1932. I believe I should modify that — apparently there still are masses of people in our nation who still are deluded by the belief that the present "*Great White Father*" in the White House can solve our problem. Here is why I say that:

From all over the country we get letters (*copies of their letters to their Representatives and Senators*) from people wondering why the President and the Congress are doing virtually nothing about the violence and disorder, the looting and the thievery and the murder which have been going on in many of the principal cities of the nation under the guise of expressing "*racial*" resentments.

The quick answer given by Administration officials is that this is *a local matter for the States or for the Cities*. Yet, only a few months ago the very same officials told the American people that racial relations "*affect inter-state commerce*," and that this was the main reason for passing the "CIVIL RIGHTS" law.

Actually, under that law, civil rights are being taken daily from innocent (*White*) citizens. Not only have the latest riots involved public places of business — *interfering with commerce* — but the hotels in New York city report many cancellations of reservations made by would-be customers from various states . . . simply because the people are afraid to come into the New York city that is now a veritable African jungle where even the police cannot provide protection.

As proof for their fears, today there are threats to limit the activities of the local police and lodge authority in civilian boards in New York (*and other cities*) to review and reverse the acts of the

police on grounds of alleged "police brutality" — and all those civilian boards are to be predominantly composed of Negro "Reverends" and other Negro "Leaders" . . . Moreover, those same "Leaders" now arrogantly demand what no one can or dare give them — such as disarming the police and exclusive employment of Negro policemen in Negro districts.

Now here is a fact that cannot be disputed: If police officers were obeyed, there would be no occasion for disputes about "brutality." But nothing is being done, or is even being contemplated to discourage resistance to arrest. Here is a concrete example of what I mean: When Gov. Bryant of Florida temporarily banned night demonstrations — *very sensibly* — in riot-torn St. Augustine, a Federal Judge, *to the everlasting disgrace of all of our Judiciary*, held the governor in violation of the Federal Constitution! *Get that!* If even a governor cannot take necessary measures to preserve order, who can?

Many members of Congress have watched with dismay and horror the various riots — and Johnson has spoken of them as "regrettable." But he has refused to repudiate, or even reprimand, any of the Negro "Leaders" and "Organizations" involved *which assure him of their political support in November!* Johnson and his Cabinet officials are quick to condemn the Ku Klux Klan or the John Birch Society by name and call them "extremists," but Johnson, in his official capacity as the leader of the Democratic Party, has never yet spoken out against, *or named*, the individuals as well as the "organizations" which have been telling the Negroes that "civil disobedience" is all right. He never even tsk-tsk'd when some of those "Leaders" openly and publicly urged their followers to arm themselves with guns and shoot down all Whites, *men and women*, who get in their way. About as far as our "great President" has gone in the matter was to make this declaration after the Rochester, N. Y., riots:

"When machinery does not exist to redress grievances, it is understandable that those who are aggrieved will take to the streets, whether rightly or wrongly. Their judgment might be wrong as to how justice could be obtained, but they would be less than human if they did not seek justice any way they can."

That was what our PRESIDENT said. *That statement was tacit approval of all the Negro rioting* — it was a *deliberate* statement for the purpose of convincing all Negroes that they must vote that kind of a "Protector" into the White House . . . But now let's ask Mister Johnson: Is looting stores the way "to seek justice?" After the riots, a civic leader in Rochester stated:

"They weren't 'demonstrating' for anything. They used the riots as an excuse to see how much they could get away with — wrecking and sacking hundreds of stores — but making sure they cleared out the liquor stores first. They got away with enough liquor to keep them drunk for six months" . . . similar statements were made by civic leaders in ALL the riot-torn cities.

But when efforts are made to arrest the most vicious of the offenders, leaders of the Negro organizations promptly cry out that it is "*police brutality*." And all the "*Do-Gooders*," the "*Bleeding-Hearts*," the "*Liberals*" and "*One-Worlders*," their voices dripping *righteous indignation*, piously join in the same cry. *Talk about the thief who yells "Stop Thief!" to divert suspicion from himself!*

And now, Fellow-Americans, let's stop talking — all time for TALK is long past. Today we must have ACTION — ACTION is the only thing that can save our Country . . . *if it is not already too late!* This "*News-Bulletin*" clearly shows what kind of action we must have . . . every traitor in Washington MUST be driven out — out of the White House, out of Congress, out of the State Department, out of ALL other Federal Agencies. Within a few days we will send you a Special Bulletin which will contain the voting records of your Representative and your Senators — *you will know what to do! We have only two months in which to do it!* But we CAN do it even in this short time — *if all of us will pool our strength and our efforts!*

Now just one word about the White House. We have a choice between Johnson and Goldwater — but actually we have no choice. Johnson means DEATH to our nation! You will find in it Johnson's entire incredible *record* of political and every other type of crookedness. Hence, I say to you, we have only one choice: Goldwater. He *can* mean the salvation of our nation — and I sincerely believe he will be if he will be the Man in the White House.

In conclusion, let me say this: CEG has always been non-political and non-partisan. It still is.
